

Buffalo Rodeo Grounds Contract for Use

By _____ Representing _____ agrees to the following conditions in their entirety:

Required Costs:

- a. When there is an admission charge for event (including parking fees): 15% of total admission fees per day will be charged *or* \$500.00 paid for each day of the event. Must be paid upfront at the time of contract submission.
- b. Three portable bathrooms, which include a wheelchair accessible option, must be pumped after each event. The charge for pumping portable bathrooms is \$45.00 each. Tell us how many of the 3 bathrooms you will need and we will lock the others. \$45.00 charge applies to only the biffs used.
- c. An approved Buffalo Rodeo Representative must be present during the event at the cost of \$150.00 per day and must be paid at the time of contract submission.
- d. Garbage removal is the responsibility of the renter.

**Required cost includes the use of the Crow's Nest, Arena, and bleachers. Also includes the use of ten- 55 gallon blue trash barrels. Garbage bags *must* be purchased by the renter and lined in each barrel in use for event. Garbage must be removed at renters expense.

Optional Costs:

1. Upon request, there is a tractor and cultivator available for use during event. If the tractor is used, five gallons of fuel must be added after event is over and there must be a rodeo representative approved person to run the tractor. Cost is determined on price of Fuel on day of event.
2. Upon request, there are night lights available throughout the grounds. The cost to use lights is \$250.00.
3. Electric power for vendors / campers is \$20 per plug per day.

Damage/Cleanup Costs: Cleanup must to be completed within 48 hours after event.

1. A \$1,000 deposit is to be paid in advance and returned if cleanup standards are met and approved by Rodeo Association representatives. Cleanup includes the removal of all garbage bags in barrels and all litter from the crowd's nest, arena, under bleachers, parking lots, and surrounding grounds.
2. _____ is required and agrees to have an ambulance and a veterinarian (in the event there are rough stock on the grounds) present during the entire event at renters expense.

_____ agrees to provide Proof of Insurance, naming the Buffalo Rodeo Association, and the Buffalo Rodeo Association personel in the amount of one million dollars and provide a copy one month prior to the event.

During the event, the Buffalo Rodeo Association is not responsible for any accidents and/or injuries that may be incurred while using the Buffalo Rodeo Grounds.

_____ is liable for any injuries or damages to people and /or property during the period of this rental agreement as well as accidents, injuries or liabilities during any activities held at the grounds that are associated with the planning or clean up of the Renter's Event. The Renter is responsible for replacement or repair of missing or damaged property owned by the Buffalo Rodeo Association during the rental agreement period which includes preparation activities as well as clean up after the Renter's Event
